Biomarker Descriptions

ARID1A p.(Q840*) c.2518C>T

AT-rich interaction domain 1A

Background: The ARID1A gene encodes the AT-rich interaction domain 1A tumor suppressor protein¹². ARID1A, also known as BAF250A, belongs to the ARID1 subfamily that also includes AR1D1B^{12,41}. ARID1A and ARID1B are mutually exclusive subunits of the BAF variant of the SWI/SNF chromatin-remodeling complex^{41,42}. The BAF complex is a multisubunit protein that consists of SMARCB1/IN1, SMARCC1/BAF155, SMARCC2/BAF170, SMARCA4/BRG1 or SMARCA2/BRM, and ARID1A or ARID1B⁴². The BAF complex remodels chromatin at promoter and enhancer elements to alter and regulate gene expression^{42,43}. ARID1A binds to transcription factors and coactivator/corepressor complexes to alter transcription⁴¹. Recurrent inactivating mutations in BAF complex subunits, including ARID1A, lead to transcriptional dysfunction thereby, altering its tumor suppressor function⁴¹.

Alterations and prevalence: Mutations in SWI/SNF complex subunits are the most commonly mutated chromatin modulators in cancer and have been observed in 20% of all tumors⁴³. The majority of ARID1A inactivating mutations are nonsense or frameshift mutations⁴¹. Somatic mutations in ARID1A have been identified in 50% of ovarian clear cell carcinoma, 30% of endometrioid carcinoma, and 24-43% of uterine corpus endometrial carcinoma, bladder urothelial carcinoma, and stomach adenocarcinoma^{6,7,42}. In microsatellite stable (MSS) colorectal cancer, mutations in ARID1A have been observed to correlate with increased tumor mutational burden (TMB) and expression of genes involved in the immune response⁴⁴.

Potential relevance: Currently, no therapies are approved for ARID1A aberrations. However, the FDA has granted fast track designation (2022) to HSF1 pathway inhibitor, NXP-800⁴⁵, for the treatment of platinum resistant ARID1A-mutated ovarian carcinoma. Tulmimetostat⁴⁶, dual inhibitor of EZH2 and EZH1, was also granted a fast track designation (2023) for the treatment of patients with advanced, recurrent or metastatic endometrial cancer harboring ARID1A mutations and who have progressed on at least one prior line of treatment.

Microsatellite stable

<u>Background:</u> Microsatellites are short tandem repeats (STR) of 1 to 6 bases of DNA between 5 to 50 repeat units in length. There are approximately 0.5 million STRs that occupy 3% of the human genome¹⁹. Microsatellite instability (MSI) is defined as a change in the

length of a microsatellite in a tumor as compared to normal tissue^{20,21}. MSI is closely tied to the status of the mismatch repair (MMR) genes. In humans, the core MMR genes include MLH1, MSH2, MSH6, and PMS2²². Mutations and loss of expression in MMR genes, known as defective MMR (dMMR), lead to MSI. In contrast, when MMR genes lack alterations, they are referred to as MMR proficient (pMMR). Consensus criteria were first described in 1998 and defined MSI-high (MSI-H) as instability in two or more of the following five markers: BAT25, BAT26, D5S346, D2S123, and D17S250²³. Tumors with instability in one of the five markers were defined as MSI-low (MSI-L) whereas, those with instability in zero markers were defined as MS-stable (MSS)²³. Tumors classified as MSI-L are often phenotypically indistinguishable from MSS tumors and tend to be grouped with MSS^{24,25,26,27,28}. MSI-H is a hallmark of Lynch syndrome (LS), also known as hereditary non-polyposis colorectal cancer, which is caused by germline mutations in the MMR genes²¹. LS is associated with an increased risk of developing colorectal cancer, as well as other cancers, including endometrial and stomach cancer^{20,21,25,29}.

Alterations and prevalence: The MSI-H phenotype is observed in 30% of uterine corpus endothelial carcinoma, 20% of stomach adenocarcinoma, 15-20% of colon adenocarcinoma, and 5-10% of rectal adenocarcinoma^{20,21,30,31}. MSI-H is also observed in 5% of adrenal cortical carcinoma and at lower frequencies in other cancers such as esophageal, liver, and ovarian cancers^{30,31}.

Potential relevance: Anti-PD-1 immune checkpoint inhibitors including pembrolizumab³² (2014) and nivolumab³³ (2015) are approved for patients with MSI-H or dMMR colorectal cancer who have progressed following chemotherapy. Pembrolizumab³² is also approved as a single agent, for the treatment of patients with advanced endometrial carcinoma that is MSI-H or dMMR with disease progression on prior therapy who are not candidates for surgery or radiation. Importantly, pembrolizumab is approved for the treatment of MSI-H or dMMR solid tumors that have progressed following treatment, with no alternative option and is the first anti-PD-1 inhibitor to be approved with a tumor agnostic indication³². Dostarlimab³⁴ (2021) is also approved for dMMR recurrent or advanced endometrial carcinoma or solid tumors that have progressed on prior treatment and is recommended as a subsequent therapy option in dMMR/MSI-H advanced or metastatic colon or rectal cancer^{26,35}. The cytotoxic T-lymphocyte antigen 4 (CTLA-4) blocking antibody, ipilimumab³⁶ (2011), is approved alone or in combination with nivolumab in MSI-H or dMMR colorectal cancer that has progressed following treatment with chemotherapy. MSI-H may confer a favorable prognosis in colorectal cancer although outcomes vary depending on stage and tumor location^{26,37,38}. Specifically, MSI-H is a strong prognostic indicator of better overall survival (OS) and relapse free survival (RFS) in stage II as compared to stage III colorectal cancer patients³⁸. The majority of patients with tumors classified as either MSS or pMMR do not benefit from treatment with single-agent immune checkpoint inhibitors as compared to those with MSI-H tumors^{39,40}. However, checkpoint blockade with the addition of chemotherapy or targeted therapies have demonstrated response in MSS or pMMR cancers^{39,40}.

STK11 p.(D176Y) c.526G>T

serine/threonine kinase 11

<u>Background:</u> The STK11 gene, also known as liver kinase B1 (LKB1), encodes the serine/threonine kinase 11 protein. STK11 is a tumor suppressor with multiple substrates including AMP-activated protein kinase (AMPK) that regulates cell metabolism, growth, and tumor suppression¹. Germline mutations in STK11 are associated with Peutz-Jeghers syndrome, an autosomal dominant disorder, characterized by gastrointestinal polyp formation and elevated risk of neoplastic development^{2,3}.

Alterations and prevalence: Somatic mutations in STK11 have been reported in 10% of lung cancer, 4% of cervical cancer, and up to 3% of cholangiocarcinoma and uterine cancer^{4,5,6,7}. Mutations in STK11 are found to co-occur with KEAP1 and KRAS mutations in lung cancer^{6,7}. Copy number deletion leads to inactivation of STK11 in cervical, ovarian, and lung cancers, among others^{2,5,6,7,8}.

Potential relevance: Currently, no therapies are approved for STK11 aberrations. However, in 2023, the FDA granted fast track designation to a first-in-class inhibitor of the CoREST complex (Co-repressor of Repressor Element-1 Silencing Transcription), TNG-2609 in combination with an anti-PD-1 antibody, for advanced non-small cell lung cancer harboring STK11-mutations. The presence of STK11 mutations may be a mechanism of resistance to immunotherapies. Mutations in STK11 are associated with reduced expression of PD-L1, which may contribute to the ineffectiveness of anti-PD-1 immunotherapy in STK11 mutant tumors¹⁰. In a phase III clinical trial of nivolumab in lung adenocarcinoma, patients with KRAS and STK11 co-mutations demonstrated a worse (0/6) objective response rate (ORR) in comparison to patients with KRAS and TP53 co-mutations (4/7) or KRAS mutations only (2/11) (ORR= 0% vs 57.1% vs 18.25%, respectively)¹¹.

UGT1A1 p.(G71R) c.211G>A

UDP glucuronosyltransferase family 1 member A1

Background: The UGT1A1 gene encodes UDP glucuronosyltransferase family 1 member A1, a member of the UDP-glucuronosyltransferase 1A (UGT1A) subfamily of the UGT protein superfamily^{12,47}. UGTs are microsomal membrane-bound enzymes that catalyze the glucuronidation of endogenous and xenobiotic compounds and transform the lipophilic molecules into excretable, hydrophilic metabolites^{47,48}. UGTs play an important role in drug metabolism, detoxification, and metabolite homeostasis. Differential expression of UGTs can promote cancer development, disease progression, as well as drug resistance⁴⁹. Specifically,

elevated expression of UGT1As are associated with resistance to many anti-cancer drugs due to drug inactivation and lower active drug concentrations. However, reduced expression and downregulation of UGT1As are implicated in bladder and hepatocellular tumorigenesis and progression due to toxin accumulation^{49,50,51,52}. Furthermore, UGT1A1 polymorphisms, such as UGT1A1*28, UGT1A1*93, and UGT1A1*6, confer an increased risk of severe toxicity to irinotecan-based chemotherapy treatment of solid tumors, due to reduced glucuronidation of the irinotecan metabolite, SN-38⁵³.

Alterations and prevalence: Biallelic deletion of UGT1A1 has been observed in 6% of sarcoma, 3% of brain lower grade glioma and uveal melanoma, and 2% of thymoma, cervical squamous cell carcinoma, bladder urothelial carcinoma, head and neck squamous cell carcinoma, and esophageal adenocarcinoma^{6,7}.

Potential relevance: Currently, no therapies are approved for UGT1A1 aberrations.

HLA-B deletion

major histocompatibility complex, class I, B

Background: The HLA-B gene encodes the major histocompatibility complex, class I, B12. MHC (major histocompatibility complex) class I molecules are located on the cell surface of nucleated cells and present antigens from within the cell for recognition by cytotoxic T cells13. MHC class I molecules are heterodimers composed of two polypeptide chains, α and B2M14. The classical MHC class I genes include HLA-A, HLA-B, and HLA-C and encode the α polypeptide chains, which present short polypeptide chains, of 7 to 11 amino acids, to the immune system to distinguish self from non-self15,16,17. Downregulation of MHC class I promotes tumor evasion of the immune system, suggesting a tumor suppressor role for HLA-B18.

Alterations and prevalence: Somatic mutations in HLA-B are observed in 10% of diffuse large B-cell lymphoma (DLBCL), 5% of cervical squamous cell carcinoma and stomach adenocarcinoma, 4% of head and neck squamous cell carcinoma and colorectal adenocarcinoma, 3% of uterine cancer, and 2% of esophageal adenocarcinoma and skin cutaneous melanoma^{6,7}. Biallelic loss of HLA-B is observed in 5% of DLBCL^{6,7}.

Potential relevance: Currently, no therapies are approved for HLA-B aberrations.
