Biomarker Descriptions

Microsatellite stable

**Background:** Microsatellites are short tandem repeats (STR) of 1 to 6 bases of DNA between 5 to 50 repeat units in length. There are approximately 0.5 million STRs that occupy 3% of the human genome<sup>33</sup>. Microsatellite instability (MSI) is defined as a change in the length of a microsatellite in a tumor as compared to normal tissue<sup>34,35</sup>. MSI is closely tied to the status of the mismatch repair (MMR) genes. In humans, the core MMR genes include MLH1, MSH2, MSH6, and PMS2<sup>36</sup>. Mutations and loss of expression in MMR genes, known as defective MMR (dMMR), lead to MSI. In contrast, when MMR genes lack alterations, they are referred to as MMR proficient (pMMR). Consensus criteria were first described in 1998 and defined MSI-high (MSI-H) as instability in two or more of the following five markers: BAT25, BAT26, D5S346, D2S123, and D17S250<sup>37</sup>. Tumors with instability in one of the five markers were defined as MSI-low (MSI-L) whereas, those with instability in zero markers were defined as MS-stable (MSS)<sup>37</sup>. Tumors classified as MSI-L are often phenotypically indistinguishable from MSS tumors and tend to be grouped with MSS<sup>38,39,40,41,42</sup>. MSI-H is a hallmark of Lynch syndrome (LS), also known as hereditary non-polyposis colorectal cancer, which is caused by germline mutations in the MMR genes<sup>35</sup>. LS is associated with an increased risk of developing colorectal cancer, as well as other cancers, including endometrial and stomach cancer<sup>34,35,39,43</sup>.

**Alterations and prevalence:** The MSI-H phenotype is observed in 30% of uterine corpus endothelial carcinoma, 20% of stomach adenocarcinoma, 15-20% of colon adenocarcinoma, and 5-10% of rectal adenocarcinoma<sup>34,35,44,45</sup>. MSI-H is also observed in 5% of adrenal cortical carcinoma and at lower frequencies in other cancers such as esophageal, liver, and ovarian cancers<sup>44,45</sup>.

**Potential relevance:** Anti-PD-1 immune checkpoint inhibitors including pembrolizumab<sup>46</sup> (2014) and nivolumab<sup>47</sup> (2015) are approved for patients with MSI-H or dMMR colorectal cancer who have progressed following chemotherapy. Pembrolizumab<sup>46</sup> is also approved as a single agent, for the treatment of patients with advanced endometrial carcinoma that is MSI-H or dMMR with disease progression on prior therapy who are not candidates for surgery or radiation. Importantly, pembrolizumab is approved for the treatment of MSI-H or dMMR solid tumors that have progressed following treatment, with no alternative option and is the first anti-PD-1 inhibitor to be approved with a tumor agnostic indication<sup>46</sup>. Dostarlimab<sup>48</sup> (2021) is also approved for dMMR recurrent or advanced endometrial carcinoma or solid tumors that have progressed on prior treatment and is recommended as a subsequent therapy option in dMMR/MSI-H advanced or metastatic colon or rectal cancer<sup>40,49</sup>. The cytotoxic T-lymphocyte antigen 4 (CTLA-4) blocking antibody, ipilimumab<sup>50</sup> (2011), is approved alone or in combination with nivolumab in MSI-H or dMMR colorectal cancer that has progressed

following treatment with chemotherapy. MSI-H may confer a favorable prognosis in colorectal cancer although outcomes vary depending on stage and tumor location<sup>40,51,52</sup>. Specifically, MSI-H is a strong prognostic indicator of better overall survival (OS) and relapse free survival (RFS) in stage II as compared to stage III colorectal cancer patients<sup>52</sup>. The majority of patients with tumors classified as either MSS or pMMR do not benefit from treatment with single-agent immune checkpoint inhibitors as compared to those with MSI-H tumors<sup>53,54</sup>. However, checkpoint blockade with the addition of chemotherapy or targeted therapies have demonstrated response in MSS or pMMR cancers<sup>53,54</sup>.

### RAF1 p.(R391W) c.1171A>T

*Raf-1 proto-oncogene, serine/threonine kinase*

**Background:** The RAF1 gene encodes the RAF-1 proto-oncogene serine/threonine kinase, a member of the RAF family of serine/threonine protein kinases which also includes ARAF and BRAF. Similar to BRAF, RAF1 (also known as CRAF) participates in the RAS/RAF/MEK/ERK signaling pathway that controls cell division, differentiation, and survival.

**Alterations and prevalence:** Although much less frequent than BRAF mutations, recurrent somatic mutations in RAF1 are observed in up to 5% of melanoma, diffuse large B-cell lymphoma, and uterine carcinoma, and up to 3% of stomach adenocarcinoma and colorectal cancer<sup>8,9</sup>. The primary recurrent mutations in RAF1 occur at codons S257 and S259<sup>9</sup>. Similar to ARAF, these RAF1 codons represent phosphorylation sites that negatively regulate RAS binding and RAF activation<sup>55</sup>. RAF1 gene amplification is observed in diverse cancer types including 10% of bladder cancer<sup>8,9</sup>.

**Potential relevance:** Currently, no therapies are approved for RAF1 aberrations. However, clinical response to sorafenib in melanoma was suggested to be associated with RAF1 gene amplification<sup>56</sup>.

### TP53 p.(A347T) c.1039G>A

*tumor protein p53*

**Background:** The TP53 gene encodes the tumor suppressor protein p53, which binds to DNA and activates transcription in response to diverse cellular stresses to induce cell cycle arrest, apoptosis, or DNA repair<sup>1</sup>. In unstressed cells, TP53 is kept inactive by targeted degradation via MDM2, a substrate recognition factor for ubiquitin-dependent proteolysis<sup>10</sup>. Alterations in TP53 are required for oncogenesis as they result in loss of protein function and gain of transforming potential<sup>11</sup>. Germline mutations in TP53 are the underlying cause of Li-Fraumeni syndrome, a complex hereditary cancer predisposition disorder associated with early-onset cancers<sup>12,13</sup>.

**Alterations and prevalence:** TP53 is the most frequently mutated gene in the cancer genome with approximately half of all cancers experiencing TP53 mutations. Ovarian, head and neck, esophageal, and lung squamous cancers have particularly high TP53 mutation rates (60-90%)<sup>8,9,14,15,16,17</sup>. Approximately two-thirds of TP53 mutations are missense mutations and several recurrent missense mutations are common, including substitutions at codons R158, R175, Y220, R248, R273, and R282<sup>8,9</sup>. Invariably, recurrent missense mutations in TP53 inactivate its ability to bind DNA and activate transcription of target genes<sup>18,19,20,21</sup>. Alterations in TP53 are also observed in pediatric cancers<sup>8,9</sup>. Somatic mutations are observed in 53% of non-Hodgkin lymphoma, 24% of soft tissue sarcoma, 19% of glioma, 13% of bone cancer, 9% of B-lymphoblastic leukemia/lymphoma, 4% of embryonal tumors, 3% of Wilms tumor and leukemia, 2% of T-lymphoblastic leukemia/lymphoma, and less than 1% of peripheral nervous system cancers (5 in 1158 cases)<sup>8,9</sup>. Biallelic loss of TP53 is observed in 10% of bone cancer, 2% of Wilms tumor, and less than 1% of B-lymphoblastic leukemia/lymphoma (2 in 731 cases) and leukemia (1 in 250 cases)<sup>8,9</sup>.

**Potential relevance:** The small molecule p53 reactivator, PC14586<sup>22</sup> (2020), received a fast track designation by the FDA for advanced tumors harboring a TP53 Y220C mutation. In addition to investigational therapies aimed at restoring wild-type TP53 activity, compounds that induce synthetic lethality are also under clinical evaluation<sup>23,24</sup>. TP53 mutation are a diagnostic marker of SHH-activated, TP53-mutant medulloblastoma<sup>25</sup>. TP53 mutations confer poor prognosis and poor risk in multiple blood cancers including AML, MDS, myeloproliferative neoplasms (MPN), and chronic lymphocytic leukemia (CLL), and acute lymphoblastic leukemia (ALL)<sup>26,27,28,29,30</sup>. In mantle cell lymphoma, TP53 mutations are associated with poor prognosis when treated with conventional therapy including hematopoietic cell transplant<sup>31</sup>. Mono- and bi-allelic mutations in TP53 confer unique characteristics in MDS, with multi-hit patients also experiencing associations with complex karyotype, few co-occurring mutations, and high-risk disease presentation as well as predicted death and leukemic transformation independent of the IPSS-R staging system<sup>32</sup>.

### HLA-A deletion, HLA-A p.(L180\*) c.539T>A

*major histocompatibility complex, class I, A*

**Background:** The HLA-A gene encodes the major histocompatibility complex, class I, A<sup>1</sup>. MHC (major histocompatibility complex) class I molecules are located on the cell surface of nucleated cells and present antigens from within the cell for recognition by cytotoxic T cells<sup>2</sup>. MHC class I molecules are heterodimers composed of two polypeptide chains, α and B2M<sup>3</sup>. The classical MHC class I genes

include HLA-A, HLA-B, and HLA-C and encode the  $\alpha$  polypeptide chains, which present short polypeptide chains, of 7 to 11 amino acids, to the immune system to distinguish self from non-self<sup>4,5,6</sup>. Downregulation of MHC class I promotes tumor evasion of the immune system, suggesting a tumor suppressor role for HLA-A<sup>7</sup>.

**Alterations and prevalence:** Somatic mutations in HLA-A are observed in 7% of diffuse large B-cell lymphoma (DLBCL), 4% of cervical squamous cell carcinoma and head and neck squamous cell carcinoma, 3% of colorectal adenocarcinoma, and 2% of uterine corpus endometrial carcinoma and stomach adenocarcinoma<sup>8,9</sup>. Biallelic loss of HLA-A is observed in 4% of DLBCL<sup>8,9</sup>.

**Potential relevance:** Currently, no therapies are approved for HLA-A aberrations.

### HLA-B deletion

*major histocompatibility complex, class I, B*

**Background:** The HLA-B gene encodes the major histocompatibility complex, class I, B<sup>1</sup>. MHC (major histocompatibility complex) class I molecules are located on the cell surface of nucleated cells and present antigens from within the cell for recognition by cytotoxic T cells<sup>2</sup>. MHC class I molecules are heterodimers composed of two polypeptide chains,  $\alpha$  and B2M<sup>3</sup>. The classical MHC class I genes include HLA-A, HLA-B, and HLA-C and encode the  $\alpha$  polypeptide chains, which present short polypeptide chains, of 7 to 11 amino acids, to the immune system to distinguish self from non-self<sup>4,5,6</sup>. Downregulation of MHC class I promotes tumor evasion of the immune system, suggesting a tumor suppressor role for HLA-B<sup>7</sup>.

**Alterations and prevalence:** Somatic mutations in HLA-B are observed in 10% of diffuse large B-cell lymphoma (DLBCL), 5% of cervical squamous cell carcinoma and stomach adenocarcinoma, 4% of head and neck squamous cell carcinoma and colorectal adenocarcinoma, 3% of uterine cancer, and 2% of esophageal adenocarcinoma and skin cutaneous melanoma<sup>8,9</sup>. Biallelic loss of HLA-B is observed in 5% of DLBCL<sup>8,9</sup>.

**Potential relevance:** Currently, no therapies are approved for HLA-B aberrations.
